1. ASSISTANT PROFESSOR - MANAGEMENT

- MBA / PGDM / or equivalent with any specialization. Preference will be given for the candidates with expertise knowledge in Retail / HR / Marketing / Finance.
- 2 years relevant experience in teaching / industry / research is desirable.
- The candidates should possess the minimum educational qualifications prescribed by the UGC/AICTE guidelines. Preference will be given to the Ph.D. degree holders in the relevant field and publications in refereed journals. Academic and industry experience is desirable.

2. ASSISTANT PROFESSOR – TEXTILES / TECHNICAL TEXTILES / APPAREL / FASHION / DESIGN

- i. M.E. / M.Tech. / Master's in Textile Design / Textile Technology / Technical Textiles / Apparel / Fashion / Textile Chemistry / Fiber Science subjects with First Class or equivalent either in B.E. / B.Tech. or M.E. / M.Tech.

- ii. A Master's degree with 55% marks or an equivalent grade in a point-scale wherever the grading system is followed in Textile and Clothing science from an Indian University, or an equivalent degree from an accredited foreign university.
