Sardar Vallabhchai Patel International School of Textiles and Management (SVPISTM) is admitting students for the three-year full-time UG and two years full-time PG courses through CUET (Central Universities Entrance Test), TANCET and SVP Entrance Test conducted by SVPISTM for the academic year 2024-25.

SVPISTM shall follow the **SVPISTM's Admission withdrawal and Refund Policy 2024- 25** formulated based on the Refund Policy 2024-25 of the University Grant Commission communicated vide Ir No : (D.O No.F.2-71/2022 (CPP-II) (C-114546) dated 12th June 2024, for the candidates provisionally admitted in a course by paying initial deposit and subsequently withdraw his/her admission.

1. Application form for refund shall be made in the prescribed format duly signed by the student and the parent along with the bank details.
2. The candidate has to surrender the Original Fee Receipt.
3. The candidate has to surrender the ID card and submit the No Due Certificate from the Head of the department. (in case the student attended the classes)
4. The refund amount will be transferred to the bank account through RTGS.
