"SVPISTM Admission Withdrawal and Refund Policy 2025-26"

Sardar Vallabhbhai Patel International School of Textiles and Management (SVPISTM) is admitting students from all over India in the three years full time UG and two years full time PG courses through either CUET (Central Universities Entrance Test) conducted by CUTN, TANCET by Govt. of Tamil Nadu or SVP Entrance Test conducted by SVPISTM for the academic year 2025-26. In case, provisionally admitted student willing to withdraw from the programme of study in which he/she has taken admission, SVPISTM shall follow **"SVPISTM Admission withdrawal and Refund Policy 2025- 26"** formulated based on the **Fee Refund Policy 2024-25 (D.O No.F.2-71/2022 (CPP-II) (C-114546) dated 12th June, 2024.**

Refund Policy:

- Any student admitted to any of the programs offered by SVPISTM may apply for a refund from studies at any time during the academic year of admission or later.
- Application form for refund must be made in the prescribed format duly signed by the student and the parent.
- Application for refund may be made either by applying along with the duly filled and signed prescribed format (**Annexure A**) in person by the student or his/her authorized representative or by applying online.

Refund Procedure:

- The refund money will be transferred to the bank account as per the account details given or cancelled cheque leaf submitted only by RTGS / NEFT.
- The paperwork for refund will be initiated ONLY on the date of receipt of the following documents.
 1. Filled application for refund
 2. Bank passbook or Cheque leaf (cancelled) of the bank to which the transfer of money is to be done.

Refund of Tuition Fess timelines:

(A)

- Receipt of withdrawal/Refund request up to 30.09.2025 – Full Amount will be refunded.
- 01.10.2025 up to 31.10.2025 – Full amount will be Refunded (Processing fee to a maximum of Rs.1000/- can be recovered)

(B)

- However, if the admission schedule is extended beyond 31st October 2025, as per the UGC guidelines issued in October 2018, the percentage of refund of fees/recoverable amount in units are given below.
