MEMORANDUM OF UNDERSTANDING made on this the 21st day of December 2021 at
the Central University of Tamil Nadu

between

CENTRAL UNIVERSITY OF TAMIL NADU (CUTN), TIRUVARUR

and

SARDAR VALLABHBHAI PATEL INTERNATIONAL SCHOOL OF TEXTILES AND
MANAGEMENT (SVPITM), COIMBATORE

This Memorandum of Understanding made on 21st day of December 2021 between Sardar Vallabhbhai Patel International School of Textiles and Management (hereinafter referred to as SVPISM which shall include its agents, authorized representatives and successors), a Society registered under the Tamil Nadu Societies Registration Act, 1975, having its office at Coimbatore, represented by its Director Dr. P. Alli Rani and set up with facilitation from the Ministry of Textiles, Govt. of India, with the primary objective of imparting comprehensive Education, Training, Consultancy and Research in Textile Management and to provide comprehensive education, training, consultancy and research in Textile Management

Central University of Tamil Nadu, established by an Act of Parliament (No.25 of 2009, 20.03.2009), represented by Prof. Sulochana Shekhar , Registrar (I/c) , having its headquarters at Thiruvarur (hereinafter referred to as the CUTN, which shall mean and include its agents, successors and authorized representatives) started by the initiative of the Central Government for promotion of Higher Education in the Country. The objective of the university is to disseminate and advance knowledge by providing instructional and research facilities in such branches of learning as it may deem fit; to educate and train manpower for the development of the country; to establish linkages with industries for promotion of science and technology; and to pay special attention to the improvement of the social and economic conditions and welfare of the people, their intellectual, academic and cultural development.

Whereas, the SVPISM has been offering three-year Under Graduate full time B.Sc. - Textiles and two-year full time Post Graduate programmes in MBA in Textile Management, Apparel Management and Retail Management and has now proposed to offer three-year full time Under Graduate Programme, B.B.A.-Textile Business Analytics, three-year full time Under Graduate Programme in B Sc.,-Technical Textiles, and two-year Post Graduate full time programme in M.B.A.-Technical Textiles Management at its main campus in Coimbatore, in collaboration with CUTN, which offer has been accepted by CUTN.

Whereas, CUTN has agreed to jointly work with the SVPISM to build up the capacity in teaching in the aforementioned Programmes.

Whereas, SVPISM and CUTN have agreed to collaborate for teaching and training in Textile Management, Apparel Management, Retail Management, Technical Textiles and Textile Business Analytics using their capacity.

Whereas, SVPISM and CUTN have agreed to reduce the terms and conditions governing the said collaboration in the form of a memorandum of understanding as follows:

1. GENERAL TERMS

- a. Various aspects of the collaboration between CUTN and SVPISM shall be guided by a monitoring committee constituted by the Vice-chancellor, CUTN, with representation from both CUTN and SVPISM.
- b. The monitoring committee may conduct an annual inspection of the infrastructure and other facilities of SVPISM under the directions of Vice-chancellor, CUTN.
- c. The terms of this MoU shall in no manner be read to prejudice the existing/future MoUs of CUTN and SVPISM with other Institutions.
- d. This MoU shall not be prejudicial to the powers, rights and interests of the authorities of the respective parties.
- e. CUTN Ordinances and Regulations will be applicable wherever appropriate.
- f. The Programmes Offered under the MoU shall have regular faculty strength as prescribed by the appropriate professional regulatory bodies.



2. PROGRAMMES OFFERED UNDER THE MOU

a. The SVPISM shall continue to offer the following programmes

- MBA-Two years (Full time)-Textile Management specialization with an intake of $40 + 4$ (EWS) = 44 students
- MBA-Two years (Full time)-Apparel Management specialization with an intake of $40 + 4$ (EWS) = 44 students
- MBA-Two years (Full time)-Retail Management specialization with an intake of $40 + 4$ (EWS) = 44 students
- B.Sc.(Textiles)-Three years (Full time) with an intake of $80 + 8$ (EWS) = 88 students

The SVPISM shall offer the following programmes from the academic year 2022-23.

- B.Sc.- Three years (Full time)-Technical Textiles with an intake of $40 + 4$ (EWS) = 44 students
- B.B.A.(Textile Business Analytics)-Three years(Full time) with an intake of $40 + 4$ (EWS) = 44 students
- MBA-Two years (Full time)-Technical Textile Management specialization with an intake of $40 + 4$ (EWS) = 44 students

- b. The programmes under this collaborative arrangement shall be subject to the approval of the Academic Council of CUTN and approval from appropriate professional regulatory bodies.
- c. The SVPISM shall design and develop the programmes under this MoU as per the Ordinances and Regulations of CUTN.
- d. The relevant criteria/guidelines stipulated by the UGC/AICTE from time-to-time for the purpose, shall be followed by the SVPISM, in appointing the faculty for teaching the aforementioned programmes.

3. DURATION OF THE PROGRAMMES, SYLLABUS AND FEES

It is agreed that the design, duration, syllabus and the fee structure of the Programmes and any other fees chargeable including the hostel fees shall be subject to the approval of the competent authorities of the CUTN.

4. ADMISSION PROCEDURE

Admission of eligible candidates to these Programmes shall be based on merit and on all India admission tests in which by CUTN participated or conducted separately or SVPISM separately or as a part of Common Entrance Test that the CUTN may participate in. Admission shall also be governed by the norms prescribed by AICTE. Input for the tests shall be given by the SVPISM. Central Government reservation norms shall be followed in the selection of candidates for admission. The admission of the candidates is subject to the approval of CUTN. CUTN nominees may be present during the counseling and admission of the candidates. The eligibility for the candidates to be admitted to the programmes shall be defined by the SVPISM, as per the UGC/ AICTE guidelines approved by BOS and CUTN Academic Council.



5. EXAMINATION

All tests, assessments and examination under this MoU shall be conducted by the SVPISM in its campus, as per the approved norms of CUTN and the results shall be published by CUTN on approval by its competent authorities. CUTN nominees may be present during the conduct of the End Semester Examinations.

6. CERTIFICATION

The Degree shall be awarded by CUTN to the students who successfully complete any programme approved under the MoU. The name of the degree shall be aligned as per the UGC/AICTE guidelines. Provisional, Migration Certificates shall be issued to the students by CUTN, on payment of prescribed fee. Transfer certificate shall be issued by SVPISM.

7. SHARING OF FEE REVENUE

1. The SVPISM may collect tuition fee and other fee as approved by CUTN from the enrolled students for providing on campus the full time programmes approved by CUTN under collaborative mode. The SVPISM will bear all the expenditure pertaining to the student support services and charge examination fee from the students, subject to the approval of CUTN. CUTN shall not provide any financial assistance or facilitation of any kind of SVPISM at any of time for the conduct of the programmes. The fees collected by SVPISM each semester from the students, under the admission, registration, enrolment and tuition fee heads shall form a single shareable pool and such pool shall be shared by SVPISM and CUTN in the ratio of 70:30 respectively. CUTN share should be remitted within a month after the commencement of classes in the particular semester. Any revision in the fee structure may be done, subject to the approval of CUTN.
2. Outstanding sharing of fee revenue as on date is agreed to transfer to CUTN within 31/12/2022 in five instalments.

8. RESIDUARY CLAUSE

This MoU can be rescinded by either party only with the approval of the Governing Council / Executive Council, as the case may be. In such an eventuality, both parties will have the obligation to support each other to abide by all Clauses / Provisions in this Memorandum of Understanding (MoU) till the batch which was admitted during the subsistence of the MoU, passes out and without prejudicing their interests. If there arises any difficulty in the implementation of this MoU, such difficulties can be removed on reference to and orders by the Vice-Chancellor of CUTN (as mutually agreed to by the parties).

9. TERMINATION

Any violation of any of the clauses in MoU shall lead to the cancellation of MoU with immediate effect.



10. DISPUTE RESOLUTION

Whereas the Parties have agreed to amicably settle all the disputes / differences arising under this MoU and in the event of failure to amicably settle the differences, either of the Party shall refer such dispute / difference to a Sole Arbitrator, mutually acceptable to the Parties. The procedure of Arbitration and situs of Arbitration shall be as decided by the Arbitrator so appointed. The Arbitration shall be governed by the Arbitration and Conciliation Act, 1996.

11. JURISDICTION

The Parties have agreed that all differences/disputes arising under this MoU shall be subject to the jurisdiction of the civil courts situated at Thiruvarur.

12. DURATION

Whereas the Parties have agreed that the duration of this MoU shall be for a period of Five years from the date of signing of this MoU or such further extended period as mutually acceptable to the Parties in writing.




